

## Acrylic Panel Warranty

- 1) Warranty duration:** Acrylic panels fabricated by Innovative Acrylics llc, LLC are warranted to be free of workmanship defects for a period of ten (10) years from date of sale.
- 2) Yellowing Discoloration:** Parent sheets are warranted against yellowing for a period of thirty (30) years from date of sale by manufacturer.
- 3) Bonds:** Are warranted against manufacturing defects for a period of ten (10) years from date of sale.
- 4) Physical properties:** Acrylic panels shall conform to Innovative Acrylics llc standards for physical properties as detailed in (B.1005 – Acrylic physical properties.pdf)
- 5) Manufacturing Specifications:** Acrylic panels shall conform to Innovative Acrylics llc standards as detailed in (B-1002 - Class 1 acrylic panel manufacturing specifications.pdf)
- 6) Evaluation of Panels Prior to Shipment:** Panels found to be defective at Innovative Acrylics llc facility prior to the original shipment shall be repaired or replaced at no additional charge to the owner/user.
- 7) Warranty Exclusions:** This warranty is limited to the original Innovative Acrylics llc purchase price of the panel. In the event of service or repair, all transportation, removal, installation or consequential expenses shall be the responsibility of the owner or user.
- 7.1) Warranty Exclusions:** This warranty does not apply to any defects caused by improper use, defective material, accidents, misuse, electrical power failure, surface deterioration of the panel caused by persons, improper cleaning procedures, cleaning with abrasive chemicals, abuse, or act of Nature. Any modification or alteration such as drilling, cutting, sawing, gluing anything to, bending, melting, tapping, or other similar means voids the warranty.
- i. Innovative Acrylics llc liability to the original purchaser is limited to the replacement value and does not extend to the contents or any other consequential damage.
  - ii. Innovative Acrylics llc shall not be liable for any loss or damage resulting from a client's willful, negligent, or a force majeure event; which was not within the reasonable control of Innovative Acrylics llc.
- 8) Maximum Liability and Consequential Damage:** The purchaser and/or user hereby agree that Innovative Acrylics llc, LLC and associates maximum liability is limited to the original purchase price in any and all circumstances. The purchaser and/or user hereby agrees to assume all liability, indemnify and hold harmless Innovative Acrylics llc, associates, its heirs, successors, agents and assigns for any consequential damage including but not limited to personal injury, property damages, business interruption losses, opening delays or other consequential damages.
